Strategic Planning Meeting Minutes October 2018

Discussed was the Financial Review, we have done a great job of reducing expenses. Direct Dues Billing: Membership Chairman, should take this on as Charlotte's hours have been reduced in an effort to cut expenses.

Also discussed: How to invest monies from the Vanguard account. First of all it needs to be determined how much money has been spent on educational projects or programs to reimburse the Foundation for money spent from their funds. Once that is determined a specific amount can be placed in an investment account and part can be put in a checking account specifically set up for educational projects and programs

Future Strategic Planning Committee location: The Missouri Credit Association has invited us to join them at their conference in Branson, MO next year. Connie Hamilton inquired if we would like to join them next October and hold the Strategic Planning meeting in conjunction with their conference. It was determined that next year's Strategic Planning Meeting should be held the 18th and 19th of October due to a prior commitment of some of the members. It was also the general consensus that not many of the members would attend our meeting if it was held in Branson. It is harder to get to and more expensive to get there.

Backup person for Gail Ottinger: Barbara Hall volunteered to be a backup for Gail Ottinger. Barb worked as a bookkeeper.

Backup person for and Charlotte Rancillio: For Charlotte Rancillio we may need to split up her duties, publications, membership and financials. It will be determined at a later time who might do what piece as backup for Charlotte. Banzai was discussed at length. Frustration establishing contact with the teachers using the program. It was suggested to send the teachers that have participated in the Banzai program a written form of contact requesting feedback and offering to publish an article from them in one of our publications. Banzai also provided scores from the teachers for their classes on pretest vs posttest scores

Publications-Linda Bridgeford reviewed different topics for articles in the magazine or newsletters All members were encouraged to write or obtain articles for publication. News is wanted from the associations and/or members for articles about local awards and from local speakers.

Take Charge of Your Life program is being taught in community colleges by Charlotte Maness. She suggested that we all look into the possibility of presenting this program in our local communities. There are some items in the *Take Charge of Your Life* program that need to be updated. Another marketing idea was to develop a CPI financial literacy program for young people or newly married couples.

We discussed doing financial literacy classes and marketing them to churches, businesses or Community Action Agencies. Ideas were discussed on ways to get CPI name out in our communities, trying to get a PSA on Public Broadcasting for CPI. We were reminded to use the social network avenues to talk up CPI & share with our friends on social media.

There was discussion about the CPI website and on ways to navigate it more efficiently.

Report of Foundation President Sharon DeShazer **CCCE/MPCE**

The CreditEducation Resources Foundation annual meeting was held Friday, June 28, 2019, which was the Foundation's 30th Anniversary. The Board members present were: Sharon DeShazer, CCCE/MPCE; Mary Nebeker, CCCE/MPCE; Connie Hamilton; Cindy Westenhofer, MPCE; Charmaine Lucas Pritchard. All CPI members were invited to attend.

The minutes of the previous meeting were reviewed and approved. The proposed budget for 2019-2020 was reviewed by Connie Hamilton and approved. There were no By-laws changes.

The approved grant request by Linda Simbeck, CFE/MPCE, on February 19, 2018, had not been dispersed. Linda cancelled that grant request on 6/20/2019 due to changes at the Credit Union.

We had a grant request by Cindy Westenhofer, MPCE, for \$10,000 for Banzai. The Grant Committee had not met before our annual meeting so no decision was announced.

Because of the declining membership, Secretary Connie Hamilton asked for a consensus of the Foundation board and the CPI members present Barbara Hall CCCE/MPCE; for continuation of the Foundation and Credit

Professionals International. The count was 12 to First year Director-Sharol Rudolph dissolve the Foundation and 20 to dissolve CPI.

Sharon appointed a committee to "Investigate our Future". The committee members are Cindy Westenhofer, MPCE; Charles Gordon; Mary Nebeker, CCCE/MPCE; and Sue Heusing, MCE. The Board approved up to \$5000 for attorney fees to answer questions that were presented and what legal issues need to be resolved.

I was Completely Positively Inspired by the members that are truly thinking about how we can continue. Yes, the organization may not look like it does today-"because 6+3=9 but so does 5+4. The way we have been doing things is not always the only way to do them."
